



LICENSED APPLICATION END USER LICENSE AGREEMENT

READ THIS LICENSED APPLICATION END USER LICENSE AGREEMENT CAREFULLY. BY DOWNLOADING OR INSTALLING THE SOFTWARE, YOU AGREE TO BE BOUND BY THIS AGREEMENT. IF YOU DO NOT AGREE TO THESE TERMS, DO NOT DOWNLOAD OR INSTALL THE LICENSED APPLICATION AND RETURN IT TO THE VENDOR FROM WHICH IT WAS OBTAINED.

This Licensed Application End User License Agreement ("Agreement") is between TIBCO Software Inc. ("Licensor") and you. The following terms shall govern your use of this software (the "Licensed Application").

The Licensed Application is licensed, not sold, to you. Licensor reserves all rights in and to the Licensed Application not expressly granted to you under this Agreement.
