New Features

The following features have been added in this release of TIBCO ActiveMatrix BusinessWorks™ Plug-in for Oracle Fusion Cloud Applications Suite.

ActiveMatrix BusinessWorks Plug-in for Oracle Fusion Cloud Apps Connection Shared Resource

With the Oracle Fusion Cloud Apps Connection Shared Resource, you can connect to the Oracle Fusion Cloud Applications Suite using either Basic Authentication or OAuth 2.0 Authentication.

ActiveMatrix BusinessWorks Plug-in for Oracle Fusion Cloud Apps Palette

The palette supports the **Consume Oracle Fusion Cloud Apps Service** activity. This activity consumes the Oracle Fusion Cloud Service that is selected and downloaded. The activity supports DELETE, GET, PATCH, and POST operations for the downloaded service.

Hot Update of Shared Resource

You can use the Hot Update feature to update application module properties and the Oracle Fusion Cloud Apps Connection Shared Resource module property without restarting the application.

The feature works for following fields in the Shared Resource:

- URL
- Identity Server URL
- Client ID
- User Name
- Scope
- Certificate
- Certificate Alias

Support for Open Telemetry (Open Tracing) Predefined Tags

ActiveMatrix BusinessWorks Plug-in for Oracle Fusion Cloud Applications Suite now supports Open Telemetry (Open Tracing) predefined tags. You can use these predefined tags to get more information about the current job being run by any activity in the palette.

Known Issues

The following issues exist in this release of TIBCO ActiveMatrix BusinessWorks™ Plug-in for Oracle Fusion Cloud Applications Suite.

Key	Summary and Workaround
BWOCE-291	<p>Summary: An unexpected error occurs when you download the swagger file on macOS.</p> <p>Workaround: None.</p>
BWOCE-275	<p>Summary: Exceptions from the Oracle Fusion Cloud system and the plug-in are not segregated. Most of the systems exceptions are captured in OERPPluginException, not in OERPSystemException.</p> <p>Workaround: None.</p>
BWOCE-240	<p>Summary: For the palette activity logger, the thread name for error code 200002 and 100006 is incorrect.</p> <p>Incorrect: bwEngThread:In-Memory Process Worker</p> <p>Correct: bwoerpconnection-threadpool-thread-</p> <p>Workaround: None.</p>
BWOCE-207	<p>Summary: The Visual diff tool shows the differences when comparing the shared resource fields, but the fields do not get highlighted.</p> <p>Workaround: None.</p>
BWOCE-147	<p>Summary: When you add a Consume Oracle Fusion Cloud Apps Service activity in a process and select GET operation, the following design time error is displayed for the optional parameter Query on the Input tab:</p> <p>Element "<API_Name>_getOp_GET_Parameters" required</p>

Key	Summary and Workaround
	<p>Workaround: To remove the errors and run the project, on the Input tab in the Properties section of the activity, right-click the input item that displays the error and select the Show Check and Repair option. In the Mapper Check and Repair window, select the items to be fixed, and click OK.</p>
BWOCE-98	<p>Summary: Search functionality on the Schema tab of Oracle Fusion Cloud Apps Connection resource does not work properly.</p> <p>Workaround: None.</p>
