


## Using White Labeling to Customize the Look and Feel of the ibi™ WebFOCUS® User Interface

In Release 9.2.0, the new White Labeling feature in the Management Center of the ibi<sup>™</sup> WebFOCUS<sup>®</sup> Hub allows you to replace the default look and feel of the ibi WebFOCUS user interface with a new look and feel based on the color palette, and branding images used by your organization.

With the White Labeling feature, you can update the favicons, browser tab label text, and banner logos on the Branding tab, as shown in the following image.



You can also replace the default color palette assigned to the WebFOCUS user interface on the Color Palette tab, as shown in the following image.




Because the changes you make using this tool impact every user, the White Labeling feature also includes options that permit you to preview, revise, or revoke your custom style choices as you develop your customizations.

No matter how you develop your customized theme for the user interface, the default WebFOCUS theme remains available at all times. As a result, you can return to the standard look and feel of the WebFOCUS user interface whenever necessary.

By using White Labeling features, you can create an environment that fits seamlessly into the look and feel of other applications maintained by your organization, and provide your users with the comfort of a familiar user environment, enhancing their adoption and use of the applications you develop.

## Ability to Control the Number of Items in a Filtered List


On the WebFOCUS Designer Visualization tab, the new *Enable paging*, *Paging threshold*, and *Items per page* options are available in the Control Settings section of the Properties panel, as shown in the following image.



You can use these settings to paginate a list of filtered options and control the maximum number of items that appear on a single list page. Using this feature, you can paginate lengthy lists of options into viewable and manageable groups. You can also help prevent users from overlooking list options that extend below the frame. ## Ability to Simplify the Calendar Picker Display


On the WebFOCUS Designer Visualization tab, the new *Enable advanced date options* check box is available in the Control Settings section of the Properties panel when a Calendar Control filter is selected, as shown in the following image.



This option is selected, by default, but you can clear it when you need to suppress the default display of the advanced date options in the date picker window. This change allows the calendar to open as soon as the date filter option is selected, instead of opening the advance date options view and requiring users to then select the Custom button to open the calendar. You can use this feature when you require additional options for advanced data range controls. For more information, see the  $ibi^{TM}$   $WebFOCUS^{@}$  User Guide.

### Ability to Configure the Initial Auto-load Feature for Visualizations

On the WebFOCUS Designer Visualization tab, the new *Enable initial auto-load* option is available in the Page Settings section of the Properties panel, as shown in the following image.



Using this option, you can choose whether or not data should automatically be loaded into all content containers when a visualization first opens. This option is selected, by default, meaning that all content loads automatically. You can clear it when you need to create a page that loads content only after users select the Refresh option.

By giving you the option to prevent the use of automatic content loading, you can use it to speed the display of complicated visualizations that contain a number of content containers. You can also use this option to allow users to limit the display of data to containers containing information relevant to a specific query.

### ibi<sup>™</sup> Data Migrator Enhancements

The following are enhancements to Data Migrator.

#### ■ API Access to Data Migrator

A new REST API has been added allowing access to Data Migrator functions from any customer application. Traditionally, these functions were only available through the Data Migrator user interface. By using the REST API, you can start or stop ETL flows, manage or retrieve information about scheduled flows, and obtain statistics about the execution of a flow from any application in your organization.

#### **☐** Common Table Expression (CTE)

In a new performance improvement to speed up ETL flows, common table expressions can now be used to simplify SQL requests when the same sub-select is used multiple times. A common table expression is a temporary named result set created from a Select statement that can be used in a subsequent Select statement.

#### ■ Notes

An enhancement to the notes feature allows you to add general notes to the canvas, as well as to the data flow, process flow, and their objects. This allows for the addition of detailed comments about the data flow, data flow objects, process flow, and process flow objects directly from the workspace. The notes appear when the flow report is printed, providing detailed documentation of the flows.

#### Optimize Load

The Optimize Load feature allows faster loading by combining insert and update operations in a flow. The option can be used with databases that use the MERGE command, as well as Insert only operations. In an enhancement to the feature, when a flow that cannot use the Optimize Load option is saved, a warning message indicating the reason is displayed and the flow is saved as a non-optimized flow giving you better understanding of how your flows execute.

#### ■ Expanded Data Lineage

Data Lineage provides the ability to see how a column was derived. It traces the column back to the data source(s) it came from, breaking down all of its components along the way. In addition to Data Lineage for primary selects, the feature has been extended to provide information for sub-selects, UNION, correlated sub-selects, and common table expressions (CTE), allowing for a more complete picture of the data lineage of a column.

## EXASol Server and SQL Automatic Passthrough (APT) Setting Enhancement

The EXASol server version is now updated to version 7.1.5 and the EXASol ODBC driver version is updated to version 7.1.14.

You can take advantage of the enhanced functionality of this new version of the EXASol server by using the recently updated SQL translator automatic passthrough (APT) processing.

In App Studio, the selection of the Transparent check box in the Background Style Properties dialog box does not assign a transparent background to the edit box and fails to assign other Background values to the edit box that are defined in the Background Properties tab. (02159105)
