FINS-2676	Response Generator created 824 loops out of order using the -fdo824x186 parameter.
FINS-2674	Response Generator 824 produces invalid file with invalid state code error. Fixed bug where missing EDAT caused an empty element to be added to the end of a TED segment.
FINS-2666	The custom report is not updating %ErrData% variable. The issue is fixed with the update in the guidelines.

FINS-2255	HVInStream reports an error, but as a GEN record, not a DTL record.
FINS-2232	Sample FSRest.ini include characters which are not loaded by TOMCAT server.
FINS-2142	Inconsistency with profile setting AllowLeadingZerosInDRG and user table.
FINS-2022	Foresight Instream fails when using guidelines with lower-

	case letters on LINUX. Foresight Instream runs properly, if the guideline is modified with all the upper-case letters.
FINS-1962	When the user process flat file, Foresight Instream fails to recognize end-of-file condition. This is because Foresight Instream is built using the Visual Studio 2012 (v110) platform toolset. The problem does not occur when Foresight Instream is built using the Visual Studio 2010 (v100) platform toolset.
