## **Closed Issues**

The following issues have been fixed in this release of TIBCO MFT Platform Server for UNIX.

Key	Description
PSU-1058	When a postprocessing Success Action fails, the transfer is set as Success, but the file is deleted because the PPA failed.
PSU-972	When a <b>Receive</b> directory fails with invalid credentials, the Log.txt transfer summary record is incorrectly written as a successful transfer.
PSU-971	When a Receive directory is executed and when the config.txt parameter LogDirectoryTransfers=N, the Initiator request to retrieve a directory list is incorrectly logged in the Log.txt file.
PSU-966	When a <b>Receive</b> directory is executed, the first transfer and the summary transfer have the same transaction ID.
PSU-965	When <b>Request Platform Server Transfer</b> is initiated using a wildcard for filename and when the <b>MaxTryCount</b> is >1, the BW " <b>Wait for Platform Server Completion</b> " times out because the audit record is written with TemporaryError=Yes.
PSU-963	The last entry from each Log.txt record is not returned on CC collector and Audit Poll requests.
PSU-959	The config.txt <b>ConfigDirectory</b> parameter is ignored when not running in HA Mode.
PSU-957	When the "lf" or "rf" parameters include a space after the colon, cfsend and cfrecv requests receive a core dump.
PSU-956	When transferring a file, if the filename contains the '%' characters, the PPA functions that reference the %LFILE token fail because the file name is corrupted.

Key	Description
PSU-954	If the <b>Log.txt TLSProtocol</b> and <b>TLSCipher</b> parameters contain corrupted data, the Command Center Collection and Audit Poll fail with a core dump.
PSU-953	When a directory list command fails because a file or directory does not exist, the transfer audit record is written as a failed transfer.
PSU-952	When a Send or Receive directory finds 0 files to transfers, there is no option to make this a successful transfer. The following config.txt [CLIENT] parameter can be added to the config.txt:
	DirTransfer0Files: F { Failure F, Success S }
	The following Template Parameter was added (TSEND, TRECV) DirTransfer0Files: F { Failure F, Success S }
	The following cfsend/cfrecv CLI parameter overrides the config.txt parameter: DirTransfer0Files:{S F}
	Shortcut: d0:{S F}
PSU-897	When partial values on components of the certificate parameters are compared, SSLAuth certificate incorrectly validates the authentication.

## **Known Issues**

The following issues exist in this release of TIBCO MFT Platform Server for UNIX.

Key	Summary
PSU-398	<b>Summary</b> : During send transfers to a distribution list, if you specify any of these parameters on the command line: encryption, SSL, port and compression, they cannot override the values defined for the nodes which are included in the distribution list.
	<b>Workaround</b> : Configure the necessary encryption, SSL, port and compression in the node definition when sending a file to a distribution list.
PSU-248	<b>Summary</b> : When you run the fusping command against TIBCO® Managed File Transfer Platform Server for Windows with earlier versions, if the license key of the Windows server has expired, a wrong message indicating a network error is displayed.
	Workaround: None.
